WHAT TO DO

People who have been sexually assaulted react in many different ways — there is no right or wrong reaction. Listed here are some important things to consider. Even if your assault happened days, weeks, months or years ago, it is never too late — or less important — for you to seek help and start your healing process.

- **Get to a safe place as soon as you can.** If the assailant poses an immediate danger to you or anyone else, alert the police as soon as possible.
- **Once you are safe, contact someone you trust** to be with you for support. This could be a friend, a family member, a resident assistant, or even a specially trained sexual assault advocate.
- **Try to preserve all physical evidence**, even if you don't know if you want to report the assault or press charges.
 - Do not eat, drink, bathe, shower, wash your hands, use the toilet or brush your teeth.
 - Do not change your clothes if possible, but if you need to change, put all of the clothes you were wearing in a paper bag and bring them with you to your medical exam.
 - Take a minute to write down everything you remember about the assault, including a description of the assailant.
- **You should seek medical care as soon as possible**, even if you don't have any apparent injuries. For more on what to expect during a postsexual assault exam, visit purdue.edu/titleix.
- **Contact the police to report the assault.** Reporting doesn't mean you have to press charges. For more on what to expect while filing a police report, visit purdue.edu/titleix.
- **Seek emotional support** to help sort out your feelings about the assault.

REPORTING OPTIONS

Reporting sexual violence or a sexual assault is not required but is highly encouraged. Victims have a number of different reporting options.

LAW ENFORCEMENT (Emergency: Call 911)

The sexual violence or assault should be reported to the agency with jurisdiction over the area where the violence or assault occurred; however, if you call any of the following, they should be able to direct you to the appropriate department.

CONFIDENTIAL REPORTING OPTIONS

Sexual violence or a sexual assault can be reported to the offices listed below and remain entirely confidential. Purdue staff from these offices are not required to report to law enforcement or other University officials identifying information about the assault, unless the victim is a minor.

NON-CONFIDENTIAL REPORTING OPTIONS

Reporting sexual violence or a sexual assault to the University is not required but is strongly encouraged so that the University may take steps to protect the safety and well-being of all University community members. These steps may include an internal University investigation, separate and distinct from the criminal justice process. Several classifications of employees have been identified as "mandatory reporters." These employees have authority and responsibility to take action to remedy harassment. Examples of mandatory reporters include:

- Vice presidents, vice chancellors, vice provosts, deans, department heads, directors and coaches
- Employees in supervisory or management roles
- Student affairs professionals

Matters reported to the office listed below will be kept as private as possible, in consideration of the victim's wishes as well as the need to ensure the safety of all University community members.

SUBMITTING A REPORT OR FILING A COMPLAINT

- Sexual Assault and Sexual Violence are, respectively, violations of the University's Title IX Harassment Policy and Anti-Harassment Policy and will be addressed accordingly.
- Sexual Assault and Sexual Violence may be reported by completing the online incident report form at purdue.edu/oie or purdue.edu/titleix.

POSSIBLE SANCTIONS

Sanctions will be decided on a case-by-case basis, must be reasonable and proportionate to the seriousness of the violation, and will be in accordance with University policy.

Possible sanctions for employees include, but are not limited to, the following:

- Letter of reprimand
- Suspension or leave of absence without pay
- Reassignment of teaching or other responsibilities
- Removal of graduate faculty certification
- Denial of a merit pay increase
- Demotion
- Probation or termination
- Restrictions on employment and/or access to University property and related organizations

Sanctions for students are listed in the Regulations Governing Student Conduct and include, without limitation:

- Verbal or written warnings
- Restrictions
- Probation
- Probated suspension
- Suspension
- Degree deferral
- Expulsion
- Restrictions on employment and/or access to University property and related organizations
